APPLICATION INSTRUCTIONS

Apply a saturating layer by brush or sprayer. Allow product to penetrate (may require surface treatment of up to 24 hours for heavy mastics and some coatings). Before removing, test area to insure surface materials have lifted. Remove lifted materials with a rag, scraper or industrial scrubbing pad (depending on tested materials and applied surface). Reapply product if necessary to remove any leftover materials. Clean finished application area with a damp cloth and/or rinse with water or industrial pressure washer.

PRECAUTIONS

Before application of product, surface area should be tested to prevent damage to substrate. Avoid prolonged application to plastics, veneers, rubber, and vinyl as product may case surface damage. Do not apply product to drywall or other gypsum-based materials without testing first. Avoid prolonged exposure to skin as product may cause skin sensitization in susceptible individuals. Avoid eye contact. Use product in a well ventilated area. Keep out of reach of children.
