II. PHYSICAL PROPERTIES

III. FIRE HAZARD

IV. REACTIVITY DATA

Enviro Care Neutral Disinfectant is stable and non-reactive.

V. HEALTH HAZARD DATA

The principal route of exposure to Enviro Care Neutral Disinfectant is skin contact. Skin contact may cause irritation. Eye contact will cause irritation. May be harmful if swallowed.

Enviro Care Neutral Disinfectant is not listed as a carcinogen by NTP, IARC, EPA or OSHA.

VI. FIRST AID

For eye contact, flush with clear water for 15 minutes. For skin contact, wash with soap and water. If ingested, or if any irritation persists, consult a physician.

VII. PRECAUTIONS FOR SAFE HANDLING AND USE

Keep out of reach of children. Avoid eye and prolonged skin contact. Do not reuse empty container. Triple rinse container before disposal.

VIII. SPILL HANDLING

If Enviro Care Neutral Disinfectant is spilled, recover liquid with wet mop or wet/dry vacuum. Flush residue to sanitary sewer with water. Use care, as floor may become slippery.

IX. SPECIAL PROTECTION INFORMATION

Rubber, neoprene or vinyl gloves should be used to minimize skin contact. Splashproof chemical safety goggles should be used to eliminate the possibility of eye contact.
